## 101.5 THE WOLF WHAT'S IN SANTA'S SACK? RULES

THE WOLF – WHAT'S IN SANTA'S SACK? CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- **1. ELIGIBILITY.** To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the Province of Ontario;
  - (b) be of the age of majority or older at the time of entry; and
  - (c) be able to accept the Prize as awarded.

2. CONTEST PERIOD. The Contest begins at 7:35 a.m. Eastern Time ("ET") on December 6, 2021 and ends at 7:50 a.m. ET on December 17, 2021 (the "Contest Period") after which time the Contest will be closed and no other entries shall be accepted.

### 3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
  - i. Listen to the station Monday to Friday at approximately 7:35 a.m. ET (the "Contest Occasion") for the "What's in Santa's Sack" cue to be announced (the "Cue to Text"). Upon hearing the Cue to Text, listeners are invited to text the entrant's name and correct Cue to Text password to (705) 750-9653 (the "Contest Line"). After five (5) minutes from the Contest Occasion, two (2) random text entries, as selected by the onair host, will be contacted to play the Contest game. The first selected entrant will be assigned as Player One and the second selected entrant will be assigned as Player Two

(each a "Contestant"). The Station will contact the Contestants at the phone number used to submit the text. If the Station is unable to reach either of the Contestants or the call back goes to voicemail (whichever comes first), another eligible entrant(s) will be randomly selected at the sole discretion of the Station.

There are ten (10) prizes to be won. Starting with Player One, the on-air hosts will provide a clue regarding what is in "Santa's Sack". Player One will have a maximum of ten (10) seconds to provide one guess regarding what is in "Santa's Sack". If Player One answers correctly, the game is over and that Contestant will win the prize described. If Player One answers incorrectly, the on-air hosts will provide a second clue for Player Two. Player Two will have a maximum of ten (10) seconds to provide one guess regarding what is in "Santa's Sack". If Player Two answers correctly, the game is over and that Contestant will win the prize described. The game will continue until either all the clues have been provided or a Contestant guesses correctly, whichever comes first. The Contestant who does not guess correctly does not win a prize but can participate in future Contest Occasions. **There will be one (1) Cue to Text per weekday.** 

- (b) Limit of one (1) entry per Cue To Text. Any Contestant who wins a Prize may not participate in any further Cues to Text during the Contest Period.
- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Streaming listeners may be listening to a delayed stream of the radio signal, which may vary depending on the device on which you are listening and the speed of the internet connection. Sponsors recommend turning on a radio to the Station for the Cue to Text. Sponsors assume no liability for entrants not making timely texts to the Station due to delays in the streamed signal.
- (e) If the telephone connection between the Station announcer and an entrant is not clear, such that the announcer and/or entrant cannot hear each other or the entrant is disconnected, that entrant may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined below) will not be liable in any way.

# 4. PRIZES.

- Peterborough, Ontario, prize is valued at approximately one-hundred and fifty Canadian dollars (CDN\$150.00);
- iii. One (1) pair of tickets to see Jeff Dunham, Friday March 11, 2022 at the Peterborough Memorial Centre, located at 151 Lansdowne Street West, Peterborough, Ontario, prize is valued at approximately one-hundred and fifty Canadian dollars (CDN\$150.00);
- iv. One (1) gas station gift card in the amount of four-hundred Canadian dollars (CDN\$400.00);
- v. One (1) supermarket gift card prize valued at four-hundred Canadian dollars (CDN\$400.00);
- vi. One (1) subscription video on-demand over-the-top streaming service gift card for in the amount of one-hundred and twenty Canadian dollars (CDN\$120.00) and one (1) subscription streaming service gift card in the amount of one-hundred and eighty Canadian dollars (CDN\$180.00). Total prize value is approximately three-hundred Canadian dollars (CDN\$300.00);
- vii. One (1) cash prize of three-hundred Canadian dollars (CDN\$300.00);
- viii. One (1) pair of tickets to see Blue Rodeo, Monday December 27, 2021 at the Peterborough Memorial Centre, located at 151 Lansdowne Street West, Peterborough, Ontario, prize is valued at approximately one-hundred and fifty Canadian dollars (CDN\$150.00) and one (1) pair of tickets to see Jeff Dunham, Friday March 11, 2022 at the Peterborough Memorial Centre, located at 151 Lansdowne Street West, Peterborough, Ontario, prize is valued at approximately one-hundred and fifty Canadian dollars (CDN\$150.00);
- ix. One (1) "Coffee For A Year" prize including one (1) gift card to be used for medium coffee, prize valued at approximately four-hundred and fifty- Canadian dollars (CDN\$450.00);
- x. One (1) gift card from Peterborough Downtown Improvement Area, located at 313 Water Street, Peterborough Ontario, prize is valued at two-hundred Canadian dollars (CDN\$200.00).
- (b) Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (c) The Sponsors and/or the Sponsors' representatives will contact the Winners to coordinate the provision of the Prizes within five (5) business days once such Winners have been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

## 5. PRIZE CONDITIONS.

(a) Should Winners be unable to participate on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.

- (b) Winners will be responsible for all incidental costs and expenses not explicitly included in the Prizes.
- (c) The terms by which the gift cards / concert tickets / experiences may be redeemed are governed by the applicable retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions relating to the gift cards / experiences /concert tickets.
- (d) In the event, Jeff Dunham, Blue Rodeo or any band members are unable to attend the concert for any reason whatsoever or in the event that the concert is cancelled for any reason whatsoever, that portion of the Prize shall be deemed fulfilled and will not be substituted, except in the sole discretion of the Sponsors.
- (e) Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. - (f) Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

### 6. WINNER SELECTION.

- (a) If there is any unawarded Prizes left at the end of the Contest Period a random draw from all losing Contestants will take place in case on or about December 18, 2021 in Peterborough, Ontario. Each entrant shall be eligible to win only one (1) Prize. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
- (b) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors and the Contestant's ability to pick up the Station's call to play the game.

Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the

Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

By entering the Contest, each entrant releases and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, exposure to the COVID-19 virus, death, or property damage, resulting in whole or in part, directly or indirectly, from: (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the entrant's participation in the Contest, without limitation.
- 9. LIMITATION OF LIABILITY. The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest.
- 10. CONDUCT. By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at <a href="https://thewolf.ca/">https://thewolf.ca/</a> throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify

any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest and/or the Contest Website or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person. CAUTION: ANY ATTEMPT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. - **12. - **TERMINATION.** The Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors.
