#### WOMEN MEAN BUSINESS RULES

THE WOMEN MEAN BUSINESS CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- 1. **ELIGIBILITY.** To be eligible for this Contest, an individual must:
- (a) be a legal resident of the province of Ontario;
- (b) be of the age of majority or older at the time of entry; and
- (c) Nominees (defined below) of entrants must: i) be a legal resident of the province of Ontario; ii) be of the age of majority or older at the time of entry; (iii) their business address must be within twenty-five (25) km of the City of Peterborough; iv) have provided consent to enter the Contest; and v) be willing to accept the Prize (defined below) as awarded.

2. **CONTEST PERIOD.** The Contest begins at 12:00 a.m. Eastern Time ("ET") on February 21, 2025 and ends at 11:59 p.m. ET on March 6, 2025 (the "Contest Period") after which time the Contest will be closed and no other entries shall be accepted.

# 3. **HOW TO ENTER.**

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
- (i) To enter online, complete and submit the entry form located at <a href="https://thewolf.ca/">https://thewolf.ca/</a> or <a href="https://thewolf.ca/">https://thewolf.ca/</a> (the "Contest Websites") including the name, address and phone number of a local, female-owned business and the name of the business owner (the "Nominee").
- (b) Limit of one (1) entry per Nominee per e-mail address per day. In the case of multiple entries, only the first eligible entry will be considered.
- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

# 4. PRIZE.

- (a) Prize. There is one (1) prize ("Prize") available to be won by the selected Nominee ("Winner") consisting of:
- (i) A two thousand Canadian dollar (CDN \$2,000.00) on-air advertising campaign with the Stations including one thousand Canadian dollars (CDN \$1,000.00) to use for advertising on CKWF-FM and one thousand Canadian dollars (CDN \$1,000.00) to use for advertising on CKRU-FM. Prize must be redeemed by August 31, 2025 and cannot be applied to advertising that has already been purchased.
- (b) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (c) The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within two (2) days once such Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

# 5. PRIZE CONDITIONS.

- (a) Winner will be responsible for all incidental costs and expenses not explicitly included in the Prize.
- (b) Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.
- (c) The Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

#### 6. WINNER SELECTION.

One (1) Winner shall be selected as follows:

- (a) On or about March 7, 2024 in Peterborough, Ontario one (1) Nominee will be selected by a random draw from all eligible entries received during the Contest Period. Before being declared a Winner, the selected nominee shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
- (b) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors.
- (c) THE SELECTED NOMINEE WILL BE NOTIFIED BY TELEPHONE OR E-MAIL NO LATER THAN MARCH 10, 2025 AT 12:00PM AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected Nominee must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected Nominee does not respond accordingly, he/she will be disqualified and will not receive a Prize and another Nominee may be selected in the Sponsors' sole discretion until such time as a Nominee satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected Nominee to receive notification or for the Sponsors to receive a selected Nominee's response.
- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
- 7. **RELEASE.** Winner will be required to execute a legal agreement and release ("Release") that confirms Winner's: (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of each of the Sponsors and their respective parent companies, subsidiaries, affiliates and/or related companies and each of their employees, directors, officers, suppliers,

- 8. **INDEMNIFICATION BY ENTRANT.** By entering the Contest, each entrant and Nominee releases and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, exposure to the COVID-19 virus, death, or property damage, resulting in whole or in part, directly or indirectly, from: (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant and Nominee agrees to fully indemnify Releasees from any and all claims by third parties relating to the entrant's participation in the Contest, without limitation.
- 9. **LIMITATION OF LIABILITY.** The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Website.
- 10. **CONDUCT**. By participating in the Contest, each entrant and Nominee is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Websites throughout the Contest Period. Each entrant and Nominee further agree to be bound by the decisions of the Sponsors shall be final and binding in all respects. The Sponsors reserve the right, in their sole

- 13. **TERMINATION.** The Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. **LAW.** These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with

the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
