WOLF "DASH FOR CASH" CONTEST RULES

THE WOLF "DASH FOR CASH" CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. ENTRANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of the province of Ontario;
 - (b) be of the age of majority or older at the time of entry in the province of Ontario; and
 - (c) reside within a fifty (50) kilometer radius of the city of Peterborough, Ontario.
- 1.2 The following people are not eligible to enter the Contest:
 - (a) Employees of Corus Radio Inc., operating as CKWF-FM (the "Station") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "Corus");
 - (b) Employees of James Campbell Inc, its affiliates, subsidiaries, related companies, successors and assigns (collectively, "McDonald's Restaurants", together with Corus, the "Sponsors");
 - (c) The employees, affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies, of each of the following companies: (i) Lakeview Bowl; (ii) Bruiser Automotive; (iii) Chemong Chimney; (iv) Electric City Dental; (v) Focus Flooring Centre; (vi) Kawartha Tv & Stereo: (vii) Kings Auto Wreckers; (viii) Marty Moos Family Restaurant; (ix) Peterborough Bath Renovators; and (x) The Old Railroad Stop;
 - (d) Any person who has been confirmed as a winner of two (2) Corus administered contests within two (2) years preceding the Contest start date indicated below where the prize was valued over two thousand five hundred Canadian dollars (CDN \$2,500.00); and
 - (e) The household members of any of the parties listed in Section (a) to (d) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.
- 2. CONTEST PERIOD. The Contest begins at 7:00 a.m. Eastern Time ("ET") on September 8, 2025

and ends at 4:10 p.m. ET on October 3, 2025, after which time the Contest will be closed and no further entries shall be accepted. The Contest shall consist of four (4) contest periods (each, a "Contest Period"), which run on the following dates:

3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (a) To enter, complete and submit the entry form located at https://thewolf.ca/contest/31849/dash-for-cash/ (the "Contest Microsite") to enter a draw for a chance to play the Cue to Call Game (defined below).
- 3.2 At the end of each Contest Period, all entries will roll over into the next Contest Period.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the applicable Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.
- 3.5 Streaming listeners may be listening to a delayed stream of the radio signal, which may vary depending on the device on which you are listening and the speed of the internet connection. Sponsors recommend turning on a radio to the Station for the Cue to Call. Sponsors assume no liability for entrants not making timely texts to the Station due to delays in the streamed signal.
- 3.6 If the telephone connection between the Station announcer and an entrant is not clear, such that the announcer and/or entrant cannot hear each other or the entrant is disconnected, that entrant may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined below) will not be liable in any way.

4. PRIZES.

- 4.1 There is a maximum of seventy-six (76) qualifying prizes (each a "Qualifying Prize", collectively the "Qualifying Prizes"), available to be won by the Qualifying Prize winners (each a "Qualifying Prize Winner, collectively the "Qualifying Prize Winners"), each consisting of a McDonald's prize pack (each containing two (2) coupons for a McDonald's Extra Value Meal), with each prize pack having a value of Forty Canadian dollars (CDN\$40).
- 4.2 There are four (4) grand prizes (each, a "Grand Prize", collectively, the "Grand Prizes"), available to be won by the Grand Prize winner (each, a "Grand Prize Winner", collectively, the "Grand Prize Winners"), each consisting of One Thousand Canadian dollars (CDN\$1,000).
- 4.3 Grand Prizes and Qualifying Prizes are hereafter collectively referred to as "**Prize**" or "**Prizes**". Grand Prize Winners and Qualifying Prize Winners are hereafter collectively referred to as a "**Winner**" or "**Winners**".
- 4.4 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.5 Prizes will be distributed within two (2) days after each Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 In the case of event tickets, gift cards or gift certificates, the terms by which the event tickets, gift cards or gift certificates may be redeemed are governed by the applicable retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions of the event tickets, gift cards or gift certificates.
- 5.2 Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.
- 5.3 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

6. SELECTION.

- 6.1 One Hundred and Fifty-Two (152) Contestants (defined below) shall be selected as follows:
 - (a) Each weekday during the Contest Periods (excluding statutory holidays), at approximately 7:00 a.m., 8:00 a.m., 1:00 p.m., and 4:00 p.m. ET, two (2) entrants (each a "Contestant", together the "Contestants") will be randomly selected from the pool of entrants, and announced on the Station together with a cue to call (the "Cue to Call").
 - (b) Upon hearing the Cue to Call, the Contestants will have ten (10) minutes and fifteen (15) seconds to call the Station, at the following phone number: 705-740-9653 (the "Contest Line").

- (c) The first Contestant to successfully get through the Contest Line within the allotted time after the Cue to Call shall win a Qualifying Prize and be entered into the draw for the Grand Prize for the respective Contest Period (the "Grand Prize Finalist").
- (d) The Contestant that is not the first to get through the Conest Line after the Cue to Call will be re-entered in the pool of entrants and have a chance to be announced as a Contestant on future Cue to Call.
- (e) In the event that neither of the two (2) Contestants gets through the Contest Line within the allotted time, there will be no Winner for that Cue to Call..

6.2 Four (4) Grand Prize Winners shall be selected as follows

- (a) On or about each of September 15, 2025, September 22, 2025, September 29, 2025, and October 6, 2025, in Peterborough, Ontario, one (1) Finalist will be selected by a random draw from all eligible Finalists received during the preceding Contest Period. Each Finalist shall be eligible to win only one (1) Grand Prize. The odds of being selected as a potential winner are dependent upon the number of Finalists determined. Before being declared a Grand Prize Winner, each selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).
- (b) EACH SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE AND/OR E-MAIL NO LATER THAN 07:30 am ET on the date of the respective draw AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive the Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
- 7. **RELEASE.** Potential Winners will be required to execute a legal agreement and release ("**Release**") that confirms each potential Winner's: (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of each of the Sponsors and each of their employees, directors, officers, suppliers, agents, sponsors, administrators, licensees, representatives, advertising, media buying and promotional agencies (collectively, the "**Releasees**") from any and all liability for any loss, harm, damages, cost or expense arising out of participation in the Contest, participation in any Contest-related activity or the acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction

of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom; and (iv) grant to the Sponsors of the unrestricted right, in the Sponsors' collective or individual discretion, to produce, reproduce, display, publish, convert, post, serve, broadcast, exhibit, distribute, adapt and otherwise use or re-use the Winner's name, statements, image, likeness, voice and biography, in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof. The executed Release must be returned within four (4) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.

- 8. INDEMNIFICATION BY ENTRANT. By entering the Contest, each entrant releases, indemnifies and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, exposure to the COVID-19 virus, death, or property damage, resulting in whole or in part, directly or indirectly, from (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.
- **9. LIMITATION OF LIABILITY.** The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Microsite.
- 10. **CONDUCT.** By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Microsite and made available throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest and/or the Contest Microsite or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person. 11.1 By entering the Contest, each entrant expressly consents to Corus and its third-party agents and

service providers, to collect, use, store, and share any personal information submitted by entrant to enter the Contest, such as name, age of majority confirmation, and contact information, as applicable, only for the purpose of implementing, administering, and fulfilling the Contest as described in these Contest Rules, and in accordance with Corus' Privacy Policy, available at http://www.corusent.com/privacy-policy.

- 11.2 Each Winner further consents that: (a) any personal information they have provided in connection with this Contest may be shared with McDonald's Restaurants for the purpose of facilitating the delivery or fulfillment of a Prize; and (b) Corus may broadcast, publish, disseminate and otherwise use a Winner's name, city/town/village and province/territory of residence, image and/or voice in connection with any promotion and/or publicity purposes without further compensation to Winner.
- 11.3 No communication unrelated to the Contest, commercial or otherwise, will be sent to the entrant unless the entrant otherwise expressly agrees to receive further communications from Sponsors.

The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
- **DISCREPANCY.** In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern and control.
